Important Local CURE Deadline Updates: More Time to Claim Funding for Reimbursement and Grants

Congress has recently modified the CARES Act to expand the deadline for Coronavirus Relief Fund (CRF) allocations to states and localities. As such, the State is modifying the Local CURE program to allow local governments (LGUs) more time to claim CFR funds allocated to them.

Changes to the Local CURE program will permit LGUs the needed flexibility to submit costs for reimbursement under both the core Local CURE program and Local CURE's Economic Support Payments (ES) Program.

The deadline to submit costs for reimbursement will be expanded to January 31, 2022, granting LGUs another year to submit costs incurred from March 1 – December 30, 2020.

Attention Small Businesses

Expanded Technical Assistance and Resources Available to Assist During COVID-19

With new rounds of federal COVID-19 emergency funding programs opening for applications, the Illinois Department of Commerce (DCEO) has expanded direct support available to businesses to help them learn which programs they may qualify for, how to navigate application processes, and to get further assistance that can help recover and grow their business. These resources are available to help with accessing the renewed Paycheck Protection Program (PPP) and other programs set to launch in the coming weeks, including the EIDL Advance and Shuttered Venue Operators (SVO) grant programs. Businesses in need of information and assistance have several options to access, including the **Illinois Small Business Development Centers (SBDCs)**, **Community Navigators**, DCEO's **Office of Regional Economic Development (Team RED)** and **Office of Minority Economic Empowerment (OMEE)**. More information on the state's expanded small business assistance, including nearly 100 virtual events hosted through the end of February, can be found below.

- **Illinois Small Business Development Centers (SBDCs):** Illinois SBDCs provide one-on-one counseling, assistance with navigating best options for financial support programs, technical assistance with documentation requirements to prepare applications, and more. Find your nearest SBDC [here](#).
- **Community Navigators:** The state is working with 12 community navigators - grassroots organizations connected with other community services. Community navigators can help determine your eligibility for programs, assist with documents, and refer to other specialized services. A full list of community navigators can be found [here](#).

- **DCEO Office of Regional Economic Development (Team RED)** and the **Office of Minority Economic Empowerment (OMEE)**: These DCEO teams provide targeted referrals and counseling for economic opportunities to businesses and communities based on geography (Team RED) and in support of minority enterprises including racial/ethnic minorities, women, persons with disabilities, and veteran-owned businesses (OMEE). Illinois Bridging the Digital Divide

Through a first-of-its-kind collaboration by the State of Illinois, PCs for People and multiple community partners, we are bridging the digital divide through a statewide network that will receive, refurbish and redistribute used computers to those in need. The Connect Illinois Computer Equity Network aims to put computers and other mobile devices into the hands of Illinois residents - assisting more families with access to high-speed internet that is essential for e-learning, remote work, and telehealth, bridging the digital divide.

Under this ambitious plan, the state will deploy over 20,000 refurbished computers annually to Illinois families. We are well on our way! Already in 2021 the program has distributed thousands of computers and mobile hotspots across the state. As part of its COVID relief efforts, the Jewish United Fund has provided \$250,000 in seed funding to jumpstart a ground-breaking initiative
